## POLICY FOR THE USE OF CERTIFICATION DOCUMENTS AND CERTIFICATION MARK

The Halal certification documents including LoC and display certificate of SANHA Pakistan are the exclusive property of SANHA Pakistan that is issued to the client once it has been confirmed in writing that the client conforms to the related Pakistan Halal Standard.

- The Halal certificate provided by SANHA PAKISTAN will be displayed at an appropriate location in Head Office and/or Factory.
- The certificate, related documentation, and any other form of authorization supplied by SANHA PAKISTAN will always remain the property of SANHA PAKISTAN.
- Not to use or permit the use of SANHA Pakistan's certification document or any part thereof in a misleading manner.
- SANHA Pakistan has the right to exercise control of ownership and to take action to deal with incorrect references to certification status or misleading use of certification documents.

Similarly, SANHA Pakistan's Certification mark/logo is a registered trademark and is an exclusive property of SANHA Pakistan which acts as an indication that a certain product is produced under any of the Halal Standards i.e. PS 3733:2022 OIC SMIIC1, SMIIC24, PS 5442, MS1500 etc, that is certified by SANHA Pakistan.

- It should always be used with a unique logo traceability code, which is assigned to all certified facilities.
- Only Halal-certified clients that hold a valid certificate of conformity may use the Certification mark/logo.
- The Certification mark may only be used for products that have been identified in the certificate (LOC).
- Usage of the SANHA Pakistan Certification mark on the packaging/labeling of certified products must be approved by SANHA Pakistan prior to use.
- The Certification mark can be used along with other certifications, logos, or trade Certification marks.
- The Certification mark cannot be used along with Non-Muslim Halal Certification Bodies Mark, also, SANHA Pakistan shall not use any other non-Muslim organization's logo/mark/symbol/slogan or any other ones reminding non-Muslims' beliefs or organizations.
- This mark shall not be used for product(s) service(s) and management system or on product packaging seen by the consumer or in any other way that may be interpreted as denoting product conformity.
- Halal certificate owners who failed to renew their Halal certificates will not be allowed to use the Halal mark at all.
- Incorrect references to the certification mark, or misleading use of the mark, or any other mechanism
  for indicating a product is certified, found in documentation or other publicity, shall be dealt with by
  suitable action.
- There should be no misleading claims regarding the meaning of the Certification Mark.
- There shall be no ambiguity in the mark or accompanying text, as to what has been certified.
- Any packaging bearing a product shape, name, picture, or serving suggestion which has a connotation
  with Haraam e.g., pork, wine (KHAMER), ham, bacon, streaky crackle, sherry, cognac, brandy, whisky,
  rum & raisin, pork spice, hot dog, etc. shall not carry the SANHA Halal mark/logo.
- It is imperative that all draft artwork bearing the SANHA logo be signed off by SANHA offices prior to print.
