# SANHA Pakistan Halal Certification Fee Policy:

At SANHA Pakistan, we are committed to providing reliable and credible Halal certification services to organizations seeking Halal certification. Our fee structure is designed to accommodate the size of the organization, the number of auditors required, and other factors that influence the certification process. The following outlines our fee policy:

#### 1. Initial Assessment Fee:

The initial assessment fee covers the evaluation of the organization's readiness for Halal certification. This includes a review of documentation, Raw material evaluation, site visits, and preliminary Stage 1 and Stage 2 Audits. The fee for the initial assessment is based on the complexity and size of the organization.

## Fee (Tentative):

- Application Cost: 15000 PKR
- Stages 1 & and 2 Cost 12,000 PKR within a city and 17,000 PKR out of the city per man-day.
- Raw material evaluation.
- Under 50RM at 1000PKR/RM,
- Under 100RM 750 PKR/RM and
- More than 100 RM lump sum amount will be charged.
- Admin/Legal cost 8000 PKR
- Travelling / Accommodation Provided by Applicant

#### 2. Surveillance Audit Fee:

The surveillance audit fee is payable annually for the subsequent two years following the initial certification. This fee covers the cost of surveillance audits conducted to ensure the organization maintains compliance with Halal standards and requirements. The surveillance audits assess the organization's ongoing adherence to the certification criteria.

## 3. Recertification Audit Fee:

The recertification audit fee is applicable after the completion of the surveillance audit cycle. It covers the cost of the comprehensive on-site audit conducted to reassess the organization's continued compliance
